## REIMBURSEMENT RULES

Please see below some key information on the upcoming conference and WGs (Working Group) meetings in Bucharest, Romania:

#### When?

The conference will take place on May 16th, with CG (Core Group) meeting and WG (Working Group) meetings on May 17th.

#### Where?

The event will be held in **Bucharest, Romania**, at the headquarters of the National University of Political Studies and Public Administration (Address: Street Expoziției, 30A, District 1, Bucharest).

## What?

The focus of the conference is on "Good practices and lessons learned in the evaluation of social policies. Social Inclusion, Social Innovation, Quality of Life and Public Health".

Face-to-face participants who are members of PROFEEDBACK can request reimbursement for travel expenses and daily allowances, following COST rules and the conference's special reimbursement guidelines.

Reimbursement guidelines for the conference and WGs Meetings during the conference days:

- Travel Costs: You can be reimbursed up to a maximum of 300 EUR for a roundtrip. This is in line with the decision made on August 25th, 2023, by the Management Committee.
- Daily Allowance on Conference Day (May 16<sup>th</sup>): Only speakers and presenters at the conference are eligible for a daily allowance. For each paper / study /research presented, the expenses related to the participation in the conference can be reimbursed for maximum 2 presenters.
- All CG members are entitled to reimbursement for their daily allowance on the Conference Day.
- Daily Allowance on WG Meeting Day (May 17<sup>th</sup>): All WGs members are entitled to reimbursement for their daily allowance.

To be eligible for reimbursement, participants must:

- Register using the Google Form (will be soon submitted to all participants),
- Accept the e-COST invitation,
- Sign the attendance list in Bucharest during the event,

• Be eligible to receive financial support (see page 60 of the COST Annotated Rules).
